Announcing the Qualies Clinical Quality Achievements at Community Health Centers Honored

DENVER— In a red-carpet ceremony on March 11, the Colorado Community Health Network (CCHN) announced the winners of the 2010 Qualies, awards recognizing clinical quality achievement at Colorado's federally qualified Community Health Centers (CHCs). CHC teams from across the state were recognized for their work to meet high clinical quality standards for emergency preparedness, blood pressure control, improvements in screenings and follow-up services in women's health, and increased immunization rates for children. In addition, physicians selected for loan repayment awards who showed exemplary commitment and service to underserved populations and communities were honored.

"It is not accidental that national health reform proposals recognize the important role of federally qualified Community Health Centers and other community clinics in our efforts to improve and reform the health care service delivery system," said guest speaker Joan Henneberry, executive director of the Colorado Department of Health Care Policy and Financing. "You are vital to our plans and progress in Colorado and essential in our desire to ensure access to quality, cost effective services for all Coloradans," she told the gathering.

The awards, finalists, and winners:

The **Masters of Disaster Award**: The nominees were CHCs who are in compliance with HRSA Health Center Emergency Management Program Expectations, the Colorado Board of Health bioterrorism regulations, and the National Incident Management System objectives. CCHN's Emergency Preparedness Program began in November 2006 to provide support and resources to CHCs.

The **Hypertension Hero Award**: The Heart Smart Navigation Program aims to increase the number of adult CHC patients who have controlled blood pressure. The Hypertension Hero Award was given to the CHC team with the greatest percentage increase in blood pressure control among adult patients with cardiovascular disease and/or hypertension between June 2009 and December 2009.

The **Pink Ribbon Award**: The Healthy Woman Outreach Project improves the health of participating CHC patients by increasing their access to breast screenings and appropriate follow-up services. This award honored CHCs for outstanding commitment to women's health.

The **Best Shot Awards**: CCHN's Immunization Initiative promotes excellence in immunization delivery at Community Health Center clinics. A primary goal is to increase immunization rates for 2-year-olds to 80 percent by the end of 2010. Tier 1, Tier 2, and Tier 3 CHC clinic sites received Best Shot Awards for achieving the most improved immunization rates for 2-year-olds in 2009 as compared to 2008.

The tier designation was based on the size of a clinic site's patient population as established by the Colorado Department of Public Health and Environment for the Vaccines for Children 2009 assessment criteria. Rates were based on the Advisory Committee for Immunization Practices recommendations as reported in the Colorado Immunization Information System.

All Colorado CHCs were recognized for dedication and countless hours of staff time devoted to improving access for their patients by participation in the Women's Wellness Connection.
